OFFICE MEMORANDUM

No.G.27040/1/2021(Accts)-RIPANS/ 177 This is for information to all concerned that the undersigned is pleased to convey the approval for implementing the instructions contained in the DoPT's Office Memorandum No. A-27012/01/2023-Pers. Policy (Allowance) 14th March, 2024 regarding reimbursement of Children Education Allowance and Hostel Subsidy in accordance with New Education Policy 2020 as under:

1. The CEA and hostel subsidy is admissible in respect of children studying from three classes before one to 12th standard (irrespective of nomenclature of class) and also for the initial two years of a diploma/certificate course from Polytechnic/ITI/Engineering College, if the child pursues the course after passing 10th standard and the employee has not been granted CEA/hostel subsidy in respect of the child for studies in 11th and 12th standards.
2. One time relaxation may be granted for reimbursement of CEA/Hostel subsidy to those employees whose children have to repeat one additional class due to implementation of New Education Policy 2020.
3. This shall come in effect from the academic year 2023-24 onwards.

Employees submitting claim for three classes before one as per New Education Policy 2020 must submit certificate of implementing NEP 2020 School Education Structure issued by the School. Proforma is enclosed as Annexure B and Proforma for claim of CEA as per Annexure A shall remain unchanged.
