The Local Purchase Committee shall comprise of the following officials:

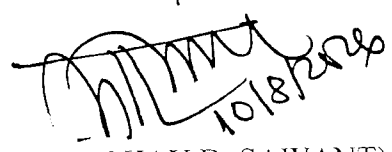

Terms of Reference & Guidelines:

1. The Committee shall survey the local market to ascertain the reasonableness of rate, quality, and specifications before recommending purchases of goods/services value above ₹50,000/- and up to ₹5,00,000/- on each occasion, in compliance with GFR provisions.

2. The Committee shall jointly issue a certificate of suitability, market rate comparison, and quality assurance prior to approval of procurement by Competent Authority.
3. The quorum for holding any LPC meeting or market evaluation of the Committee shall be at least three (03) members including the Chairman.
