### CODE OF CONDUCT FOR STUDENTS

**Regularity:** Attend all the classes regularly. Failure to meet attendance requirements as per the program regulations; submit assignments, or attend tests/exams without justification will be considered a irregularity.

**Punctuality:** Be on time in the Department for Theory, Practical and other sessions.

**Behavior:** Be honest, polite and treat others with respect.

**Discipline:** Students are expected to maintain the highest standards of discipline and dignified manner of behavior inside as well as outside Institute. They shall abide by the rules and regulations of the Institute.

**Courtesy:** Students must show courtesy to staff and fellow students, both on and off-campus, and avoid actions that could damage the Institute reputation.

**Uniform policy:** Full Uniform is mandatory with ID cards to visit Departments, Library and Offices

**Mobile Phone:** Use of Mobile Phone during class hours is prohibited and is liable for punishment.

**Prohibition:** Smoking, chewing and spitting tobacco products or pan masala, consumption of alcohol and narcotic drugs is strictly prohibited inside the Institute premises. Violation of this rule will invite disciplinary action. The Institute premises is a non-smoking zone, respect it.

**Amenities:** Utilize amenities provided by the Institute with care. Use designated areas for independent Study, Library and Computing facilities. Refrain from mishandling and tampering with Library Books, Computer Systems and any other property.
