5. 14 Unreserved (UR) seats are then given to the candidates based on their inter-se-merit.
6. Since, there were no candidate for PWD, the seat was given as UR category to the candidates based on inter-se-merit.
7. All the selected candidates are informed to complete admission on or before 12th August, 2024 during office hour. All admission fees must be paid through online in the link provided through email of the selected candidate. Selected candidate who does not complete online admission process within the stipulated period will result in cancellation of the allotted seat in M.Pharm Program without any further information.
8. Verification of documents will held on 19th August, 2024. Failing which, the allotted seat in M.Pharm will stands cancelled.
9. The selected candidates who are presently under the Government service are required to obtain and submit permission (study leave) for studying M. Pharm at RIPANS from the concerned authority on or before 10th September, 2024.
10. Academic session will commence from 19th August, 2024.
11. Second counselling will be held on 21st August, 2024, if required.
