कार्यालय आदेश /OFFICE ORDER

No.D.32021/1/2026-RIPANS(Vol-II)/61: It has come to the notice of the undersigned that some students, hostellers, day scholars, and even outsiders are using the internal roads of the Institute campus for performing motorcycle/bike stunts. Such activities are highly inappropriate, unsafe, and pose a serious risk to pedestrians, patients, staff members, students, and other road users within the campus.

In view of the above, performing motorcycle/bike stunts, rash driving, racing, wheeling, or any other dangerous vehicular activities within the Institute campus is **strictly prohibited** with immediate effect. All hostellers and day scholars are hereby directed to adhere to the following instructions:

1. Motorcycle/bike stunts and reckless driving within the campus are strictly prohibited.
2. The maximum speed limit within the Institute campus shall be **20 km/hr**.
3. All vehicle users shall drive cautiously and follow traffic discipline at all times.
4. Any student found violating these instructions shall be liable for disciplinary action, including imposition of a fine, suspension of campus driving privileges, and/or expulsion from the Institute, depending upon the gravity of the offence.
5. Outsiders found indulging in such activities shall be denied entry into the campus and appropriate action shall be taken as deemed fit.

All concerned are requested to comply with this Office Order in the interest of safety, security, and maintenance of discipline within the campus.
